

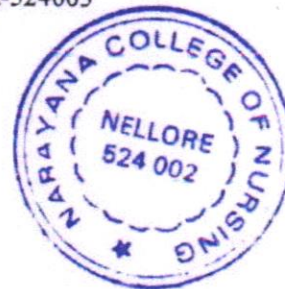



St Paul hospital was built in 1969 as an autonomous higher education institution under federal minister of health located at Addis Ababa, Ethiopia, it currently has 392 beds with annual average of 200,000 patients and catchment population of 5million. The medical school opened in 2007, the new millennium era of the Ethiopia calendar, on top of this residency program in different field of study offered such as surgery, Gynecology, ENT, nephrology, internal medicine, ophthalmology, maxillofacial surgery, epidemiology etc.

St Paul Hospital Millennium Medical College (SPHMMC) nursing education directorate started the two specialty nursing program namely operating theatre and emergency and critical care in March 2012 in collaboration with Trauma care Ethiopia and children burn care foundation. Currently we have three batches of students in each department and total number of enrolled students is 300. The number of staff is nearly 40 in a range of Graduate assistant (B.Sc. holders) to Assistant professors also we have one PhD student who will be finishing soon.

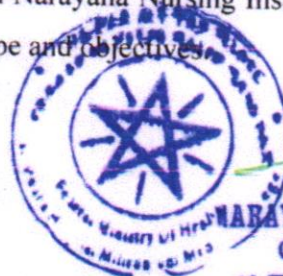



MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (Agreement) is made and entered into by Narayana Dental College and Hospital and Narayana Nursing College located in Chinthareddypalem, Nellore with the Center for Ethics, Yenepoya University located at Deralakatte, Mangalore.

RECITALS

Whereas the institutions are linked by common academic and healthcare interests;

Whereas the institutions wish to enable cooperation and exchange in all academic and healthcare areas of mutual interests; and

Whereas the institutions wish to enable cooperation and exchange in all academic and healthcare areas of mutual interests; and

Whereas the institutions wish to develop the basis for better understanding of bioethics, their implementation in research protocols & processes utilizing the faculty and facilities available in both the institutions;

Therefore, in consideration of their mutual interests and the covenants set forth herein, the institutions agree as follows:

ARTICLE 1

PURPOSE AND SCOPE OF THE AGREEMENT

1.01 **Purpose.** The purposes of this agreement include, but are not limited to the following:

- a) Training of Staff in different aspects of Bioethics ;
- b) Guidance & Support for Development of Bioethics Center in Narayana Dental & Nursing Institutions;
- c) Organizing joint academic and scientific activities such as courses, conferences, seminars, symposia, or lectures;
- d) Exchange of research and teaching personnel;
- e) Exchange of publications and other materials of common interest.

1.02 **Scope.** Cooperative projects under this agreement may include any of the academic disciplines represented at either of the institutions.

ARTICLE 2

PROPOSED ACTIVITIES PURSUANT TO THE AGREEMENT

2.01 **Institutional Appointees.** In order to carry out and fulfill the aims of this agreement, each institution will appoint an appropriate person at each of their campuses to coordinate the development and conduct of joint activities. Through these contact persons, either institution may initiate proposals for activities under this agreement. The contact persons will additionally be responsible for evaluation of activities under this agreement according to the practices of their respective institutions.

2.02 Supplemental Agreements. Activities the institutions mutually agree to undertake are subject to further agreement of the institutions & must be set forth in supplemental agreement signed by authorized representatives of each institution. Supplemental agreements should include specific details of the agreed upon activity, including items such as : (a) elaboration of responsibilities of each institution for the agreed upon activity; (b) schedules for specific activities; (c) budgets & sources of financing for each activity; (d) any other items necessary for efficient conduct of the activity and (e) any other items necessary to meet the legal and policy requirements of each institution. Supplemental agreements are subject to approval by each institution according to the normal policies & procedures governing the types of activities proposed therein.

ARTICLE 3

TERM AND TERMINATION
