ADMISSION POLICY

Admission Policy Statement

Narayana College of Nursing is to foster a dynamic, diverse, and inclusive learning environment dedicated to preparing compassionate, skilled healthcare professionals. We are committed to fair, transparent, and academically rigorous admission processes that align with the values and standards of the nursing profession.

Objective:

To establish transparent, merit-based, and equitable criteria for admission into various Nursing programs, ensuring candidates meet the required academic and professional standards. This policy aligns with guidelines from regulatory bodies to maintain the quality and integrity of the admissions process.

Scope:

This policy applies to the admission procedures for B.Sc. Nursing, Post Basic B.Sc. Nursing, and M.Sc. Nursing programs, including eligibility requirements, seat allocation, compliance with regulatory standards, and the application process.

1. Eligibility Criteria

B.Sc. Nursing (B.Sc. N):

- Age Requirement: Minimum age of 17 years by December 31 of the admission year.
- Educational Qualification: Completion of 10+2 with Science (Physics, Chemistry, Biology) and English, with a minimum aggregate of 45% from a recognized board (AISSCE/CBSE/ICSE/SSCE/HSCE or equivalent).
- APEAPCET, NEET Score: A valid APEAPCET (Andara Pradesh Engineering Agricultural and Pharmacy Common Entrance Test) NEET (National Eligibility cum Entrance Test) score is mandatory, used for merit-based selection.
- Medical Fitness: Candidates must be medically fit.
- Admission Frequency: Admissions occur once per year.

Post Basic B.Sc. Nursing:

• Educational Qualification: Completion of Higher Secondary or equivalent recognized qualification.

- **Professional Requirement:** Certification in General Nursing and Midwifery and R.N.R.M. registration with the State Nurses Registration Council.
- **Male Nurses:** Male nurses trained before the integrated course must provide proof of additional training in approved nursing specialties.
- Medical Fitness: Candidates must be medically fit.
- Admission Frequency: Admissions occur once per year.

M.Sc. Nursing (Nursing):

- **Registration:** Must be a Registered Nurse and midwife (or equivalent) with any State Nursing Registration Council.
- Educational Qualification: Bachelor's degree in Nursing (B.Sc. Nursing/B.Sc. Hons. Nursing/Post Basic B.Sc. Nursing) with a minimum aggregate of 55%.
- **Experience:** Minimum of one year of nursing work experience after Basic B.Sc. Nursing or before/after Post Basic B.Sc. Nursing.
- Admission Frequency: Admissions occur annually.

2. Seat Allocation

- **Quota Distribution:** Seats are equally divided between the Management Quota and Competent Authority Quota.
- Odd Seat Policy: In cases where the intake capacity is an odd number, the additional seat alternates annually between the Management and Competent Authority quotas, following G.O.Ms.No.338, HM & FW Dept., dated 16-08-2008.

3. Compliance with Affiliation and Regulatory Guidelines

All admissions strictly comply with the standards set by the affiliated university and regulatory authorities, including the Indian Nursing Council (INC) and relevant state authorities. This adherence ensures quality, transparency, and integrity in the admissions process.

4. Application Process

• **Application Timeline:** Admission notifications, including timelines and deadlines, are published annually.

EGE OF NURSING

- **APEAPCET, NEET Score Submission:** Applicants for the B.Sc. Nursing program must submit their APEAPCET, NEET scores with their applications.
- **Documentation:** Applicants are required to submit necessary documents, such as proof of eligibility, educational qualifications, APEAPCET ,NEET scorecards for B.Sc. Nursing, medical fitness certificates, and other specified documentation.
- Selection and Counseling:
 - Management Quota: Admissions may involve direct interviews or collegelevel counseling.
 - **Competent Authority Quota:** Admissions follow merit-based guidelines based on NEET scores for B.Sc. Nursing.

This policy provides a structured approach to the admission process, ensuring all candidates meet the necessary qualifications and standards for each program.
