This is beneficial as it enables people outside the core developers to comment on bugs and offer suggestions for improvement. The final, compiled product contains only code which was either written, or directly checked and approved, by NV Access. Provided download from <http://www.nvaccess.org/> can be sure that are downloading an official version of NVDA which is unaltered and free from malicious software. For blind people to use a computer, they need a screen reader which reads the text on the scene in a synthetic voice or with a Braille display. This is a critical problem, because without computers, access to education and employment is severely limited, not to mention everyday functions such as online banking, shopping and news.

Creating awareness about free screen reader called NVDA (Non Visual Desktop Access) the students and faculties for use with computers running on Windows. Creating awareness program to the patient and patient's attendees. The faculty and students learnt the features and uses of

NVDA towards public. NV Access, the organization behind the NVDA screen reader, is a registered charity in Australia. 
