### **1.SHORTTITLE**

Narayana College of Nursing's stated policy is that no deserving applicant would be denied the opportunity to study at Narayana College of Nursing solely because she seems unable to pay the fees. This comprehensive feewaiver policy has been enacted.

### **2.OBJECTIVE**

2.1. Narayana College of Nursing is waiving a portion of a tuition fee for students enrolling toUG and PG.

2.2. To entice intellectually gifted students to enrol in the institutions

2.3 To assist pupils who come from economically weaker sections and disadvantaged backgrounds.

### **3.ELIGIBILITY AND APPLICABILITY**

- 3.1. He or she would have passed a qualifying examination by one of India's institutions.
- 3.2. Students who excel in additional and cocurricular activities, while also rank holders
- 3.3. Students from the SC, ST, BC, kapu, EBC, and other divisions
- 3.4 This scheme will be accessible to students whose family members' annual income is less than.Rs.1lakh from all sources

The decision will be forwarded to the Principal for review.

The request for sanction will be addressed to Narayana Educational Society's account section for approval on every year October.

The sanction will be notified to the students by the Principal of Narayana College of Nursing.
